Mr. Harrison,

I would like to express my gratitude to your organization for the work you do in Winnipeg. A strong, viable construction industry is critical to the growth of any city in Canada. I look forward to working closely with your organization following the election at addressing your concerns and to implement the best solutions.

I appreciate the opportunity to respond to the questions and I have provided my answers below.

Question One: What would you do to ensure the permit department is adequately resourced in the future?

Issuing permits quickly and ensuring service time certainty is a priority. Anyone seeking a permit is making an investment in Winnipeg. We need to ensure that we enable investment rather than make it more difficult. An adequately resourced permit department is fundamental to our city treating those who want to invest as valuable clients of our city and not as adversaries to argue with, which is the current situation.

Question Two: Would you support changes to the Permit Reserve Fund to increase the total fund and ensure it is replenished prior to any funds leaving the permit department for consolidated revenue?

I am open to ensure our permit system is as efficient as possible, including properly funding the permit reserve fund.

Question Three: Would you support the use of the widely-accepted standardized documents (CCDC) for City of Winnipeg construction tendering?

Yes, but recognizing that for complex projects, a one size fits all approach isn't always appropriate. Contracting with the city or any public organization is different than with a private or corporate party. I would support the use of CCDC contracts which include appropriate supplemental conditions to reflect the reality of each project.

Question Four: How do you plan to balance the responsible use of taxpayer dollars and funding important infrastructure projects?

I believe that the people of Winnipeg want to elect a leader who is able to put in place policies that are consistent with their desires. This includes ensuring that we have modern infrastructure while also ensuring our property tax and other taxes are competitive. I would ensure that the professionals working for the city would be accountable to deliver the infrastructure desired by Winnipeggers at fair and reasonable prices. As a city we need to ensure value for money in construction is achieved otherwise Winnipeggers will not continue to support the city making these investments.

Question Five: What will you do to improve collaboration in the Winnipeg Metro Region to attract outside investment?
